 - Funding a wider range of sustainability initiatives, such as marketing and strategies, that promote and support a circular economy.

Council has committee in excess of \$3.5 million to extra town infrastructure projects (1.2 million preschool, 835 thousand Showgrounds function centre, 1.5 million gym, pool, kiosk and community shed. Rural roads have always been one of the top items that our ratepayers feel Council could do more to improve Furthermore as stated by GM at our last meeting Council's financial position is quiet healthy (Council moved \$2 million from the General Working funds to Internal Restricted Asset funds) I feel
